

The REALTOR® STORE Contest Rules and Regulations

Every \$150 spent at TRREB's Realtor Store Pop Up during Realtor Quest equals one ballot entry. This "REALTOR® Store Contest ("Contest") is sponsored by the Toronto Regional Real Estate Board ("TRREB"). This Contest is governed by these official rules ("Rules"). By participating in this Contest, you agree to abide by these Rules, including all eligibility requirements, and understand that the results of the Contest, as determined by TRREB, are final and binding. Any questions, comments or complaints regarding the Contest must be directed to TRREB.

ELIGIBILITY

The Contest is open to TRREB members attending TRREB REALTOR® QUEST 2026 whom both reside and have reached the age of majority in Ontario.

Entrants must not be full-time employees or Board of Directors of TRREB. TRREB has the right to verify the eligibility of each entrant.

CONTEST PERIOD

The Contest begins on May 13, 2026, at 8:30 a.m. EST and ends on May 14, 2026, at 4:00 p.m. EST only at Realtor Quest ("Contest Period"). All entries (submissions) will be received during the times stated during the Contest Period. TRREB reserves the right to extend or shorten the Contest Period at its sole discretion.

HOW TO ENTER

PURCHASE REQUIRED. Visit TRREB's Realtor Store Pop Up during the 2-day event at Realtor Quest and complete a \$150 purchase. Every \$150 spent; equals an entry. During check out, a cashier will give you a ballot where you need to fill out your name, email, phone number and member number.

The winners will receive an email the week after TRREB's REALTOR® QUEST.

Winners will pick up their prize at TRREB's office (1400 Don Mills Road). They will have five (5) business days to respond to the email and arrange a date and time to pick up their prize. The winner will also answer a skill testing question. A new winner will be randomly chosen if needed.

SELECTION OF WINNERS

All eligible entries received during the Contest Period will be entered into the Contest draw. Six (6) entries will be randomly chosen at the end of the Contest Period.

The six (6) winners will be announced after TRREB REALTOR® QUEST. Winners will be contacted by phone and email. Each entrant is responsible for monitoring and ensuring that their email account (as submitted) is active and current. Winners will be notified by TRREB and must contact TRREB within five (5) days of receipt of that email notice to claim their prize.

In order to claim a prize, winners will be required to correctly answer a time-limited mathematical skill-testing question without assistance of any kind, whether mechanical or otherwise, to be administered and

returned by email, and TRREB reserves the right to require the winners to sign and return a declaration of eligibility and release, in the format requested by the TRREB, within five (5) days from the date of delivery thereof.

If a winner cannot be reached by email by TRREB within five (5) days, does not contact TRREB within five (5) days of TRREB's email to claim the prize, does not satisfy the preceding conditions, declines the prize, the such winner shall forfeit the prize and TRREB reserves the right to select another eligible entry. Prizes may not be awarded if an insufficient number of eligible entries are received, as determined by TRREB.
